OFFICIAL RULES AND GUIDELINES:

1. GENERAL INFORMATION:

- a. **ENTERING THE COMPETITION:** Entrants must submit a demo of their performance by **April 3, 2020 at 5pm**. The submission must be a video, and may be submitted electronically to sayrebusinessassociation@gmail.com or on a DVD or thumb-drive to: **Sayre Business Association, PO Box 215, Sayre, PA 18840**. You may also submit a link to a YouTube video of your performance. The planned performance should be no more than 5 minutes in length. Those chosen to perform will be informed via email no later than April 10.
- b. **FINAL ROUND:** The final round will be in front of the public and a panel of judges on Sunday, April 26, 2020 at 3pm. Each performer who is selected to compete in the finals is welcome to watch the rest of the performance, and will also be given 1 complimentary ticket for a friend or family member.

2. STANDARDS OF PERFORMANCE:

- a. **The SBA is a community organization and will be billing this as a family event. All performances are expected to be in good taste and suitable for a PG audience. Profanity or vulgarity will not be tolerated under any circumstances and will be grounds for immediate disqualification.**
- b. By signing this form, you agree that the performance you give during the final (public) round will be substantially the same performance you gave in your demo. If you deviate from the previously performed material during the live show, your performance may be ended abruptly and you will be disqualified. If you deviate from the previously performed material, you will be held responsible and liable for any audience complaints.

3. IMAGE RELEASE:

- a. I hereby authorize the Sayre Business Association, hereafter referred to as "SBA," to publish photographs or videos taken of me

and my name and likeness, for use in the SBA's print, online, and video-based marketing materials and promotions, as well as other SBA publications. I hereby release and hold harmless SBA from any reasonable expectation of privacy or confidentiality associated with the images specified above. I further acknowledge that my participation is voluntary and that I will not receive financial compensation of any type associated with the taking or publication of these photographs/videos or participation in SBA marketing materials or other SBA publications. I acknowledge and agree that publications of said photos/videos confers no rights of ownership or royalties. I hereby release SBA, its contractors, its volunteers, and any third parties involved in the creation or publication of marketing materials, from liability for any claims by me or any third party in connection with my participation.

- b.** I also turn over all rights to my entry video, which may be used for promotional purposes prior to the performance.

4. ODDS AND JUDGING:

- a.** The odds of winning depend entirely on the number and quality of entries. Judging will be by a panel to be chosen by the SBA. Judges will be representative of the types of performers that enter and selected from the local community.
